(\*Weddings/Receptions must meet additional requirements)

1. Both areas have BBQ pits, water, and electricity hook-ups designated for that area.
2. Barbeques will be allowed in designated pits only, unless prior permission is granted.
3. Grounds will be left orderly and clean.
4. There will be no loud music or announcing systems. (Weddings/Receptions consult office)
5. Children will be kept under adult supervision.
6. All animals must be leashed at all times.
7. "No Trespassing" signs must be respected.
8. BBQ grounds are closed at 5:00 P.M. (Times negotiable upon approval)
9. User fee must be paid 60 days prior to date requested.
10. Due to our first come first serve policy for reserving our BBQ Areas, there will be no refunds for cancelled events.
11. Rescheduling is allowed for rainouts and for groups who call to reschedule prior to 14 days before their scheduled date. Groups must reschedule within 6 months of their original date.
